 - b. It's pretty much a legally binding contract between us (aka Pineapple Ventures (Pty) Ltd trading as Disrupt Tutoring or "we" or any other related pronouns) and you (Learners, Mom, Dad, Gran, Granddad, Aunt, Uncle, Teacher, Tutor, and everyone else with burning desire to learn or teach).
 - c. If you are a Sponsor, Tutor, Contributor or Affiliate, not only do we love you, but we have caringly created more specific T's and C's to guide our relationship. You'll find all of those here.
- 2. We're here to help, but we acknowledge we're only human.





- a. We're so grateful that you have made the decision (and have chatted to your parents to come to that decision) that our website is useful. We just want to make it clear that our interests are pure and all the content we upload is there to help, but we aren't bound to help.
- b. Also, every effort is made to make sure all content is totally accurate, but we may get it wrong sometimes (such is human nature). We are so grateful to you for your understanding in advance, and have put some channels in place so you can let us know when you spot and error and we will rectify it as soon as we get the chance.
- c. That said, we are not here to substitute the guidance given to you by your epic teachers. We're here to give you a feel for the practical application of some the tools you've learnt in class. With that in mind, we can't be held liable for any liability, damage and/or loss that results from you using our website, any errors in videos, or not being able to use our website.

 - c. Blog posts written by Contributors belong to the Contributor and they have given us the right to publish their post on our website. Podcasts produced by us using the blog post belong to us, but we will always pay them tribute in the audio.
- 8. Cookies (just not the ones that go so well with milk).
 - a. To make your experience that much more epic, we may collect and process cookies. But more on this in our Privacy Policy.
- 9. Just so we're clear, we're not responsible for a few things.
